



GENERAL INFORMATION CLASS OF 2030

TUITION

Tuition for the 2026-27 school year is \$21,800 consisting of either 11 monthly payments beginning in June 2026 and ending in April 2027, or one (1) full payment by June 30, 2026. If the full tuition amount of \$21,800 is paid by June 30, 2026, you will receive a \$250 discount.

IHA is partnered with **FACTS Tuition Management** who aids us in our tuition collections. All families are required to create an account on the **FACTS** system. **FACTS** annual processing fee is \$55 for monthly payments and no charge for one (1) payment in full.

Please register with **FACTS** through the online applicant portal or by visiting the IHA website, www.ihanj.com, and choosing the "Tuition & Financial Aid" tab under "Admissions." If you already have an account with **FACTS**, you do not need to create a new one, just add your daughter as an Immaculate Heart Academy student. Our school code is 5901.

AWARDS

If you received Financial Aid or an Academic Award, they will be posted to your **FACTS** account before it is finalized by IHA.

CLASS FEES

Students will receive an itemized invoice prior to September that will consist of lab fees, a graphing calculator (required for all IHA math and science classes), IDs, subscriptions, and freshman class fees. These items are required for freshman year. The estimated cost of this invoice is approximately \$700. Exact charges will depend upon individual course selections.

REGISTRATION

In addition to your initial registration of \$900, there will be a re-registration fee for sophomore, junior, and senior school years. Registration is a non-refundable fee.

ATHLETIC FEES

There is an athletic fee if your daughter participates in sports at IHA. The 2026-27 fees are as follows: 1st Sport - \$450, 2nd Sport - \$350, 3rd Sport - \$250.

RETURNED CHECK POLICY

IHA will charge a \$20 returned check fee to your account for any checks returned due to insufficient funds. If we receive three (3) returned checks on a student account, we will no longer accept a personal check and will require a certified bank check or money order.

BOOKS

Loaned NJ State Textbooks: Students will be issued textbooks at the start of school in September. Textbooks are on loan from the State of New Jersey and must be returned in June. If a book is not returned, we are required to charge you for the cost of the book.

Student-Purchased Books: You will be required to purchase religion books and possibly workbooks and/or paperbacks. The books needed will depend on your daughter's course selections that will be mailed to you in early summer. Her courses will be determined by her placement tests taken at IHA. In June, IHA will email a list of supplemental texts that families must purchase directly.

COLUMBUS CITIZENS FOUNDATION SCHOLARSHIP*

THE SCHOLARSHIP FUND FOR INNER-CITY CHILDREN*

The Scholarship Fund for Inner-City Children (SFIC) will be accepting applications for the 2026-27 school year beginning March 1, 2026. The deadline for all applications and required financial documentation is May 1, 2026. **The SFIC is independent of IHA.**

TRI-COUNTY SCHOLARSHIP FUND

Scholarships offered through the Tri-County Scholarship Fund **are independent of IHA** and are available to incoming freshman students or current high school students who reside in Morris, Passaic, or Sussex counties in New Jersey. Tri-County offers annual High School Scholarships based on financial need and Freedom Scholar Scholarships based on financial need and significant academic achievement.

Families who submit a financial aid application for IHA through FACTS will automatically be considered for these scholarships if their application is submitted by February 15, 2026.
